

# MEMORANDUM OF UNDERSTANDING

Between

**K. S. Polytechnic and Rapsol Technologies Pvt. Ltd.**

This Memorandum of Understanding (MoU) is entered into on this 22 day of JUNE, 2025, by and between:

**K. S. Polytechnic**, located at #15, Holiday Village Road, Mallasandra, Bangalore - 560062, hereinafter referred to as "*Institution*",

and

**Rapsol Technologies Pvt. Ltd.**, located at No.138/c, 2nd Floor, 2nd Main Road, 3rd Block, Thyagarajanagar, Bengaluru, Karnataka 560028, hereinafter referred to as "*Industry Partner*".

This MoU is intended to serve as a framework for mutual collaboration in the areas of skill development, knowledge exchange, and employability enhancement of students. It outlines the areas of cooperation and respective responsibilities of both parties.

This MoU aims to bridge the gap between academia and industry through collaboration in skill-based training, technical knowledge sharing, and employability support for students. The primary focus is to provide students of K. S. Polytechnic with practical exposure to real-world IT services and digital technologies, thereby enhancing their technical competencies and making them industry-ready, thereby enhancing their technical competencies and industry readiness.

**Note: This Memorandum of Understanding is not legally or financially binding, but reflects a mutual commitment to collaboration and shared objectives for the benefit of students.**

## OBJECTIVES

The key objectives of this MoU are as follows:

- To facilitate industry-relevant training and internship opportunities for students.
- To organize workshops, technical seminars, expert talks, and skill enhancement programs.
- To provide collaborative support in curriculum development and student projects.
- To offer placement support and career guidance to eligible students, including mentoring and recruitment exposure.

## **DURATION AND VALIDITY**

This MoU shall be effective from the date of signing by both parties and shall remain valid for a period of **five (5) years**. It may be extended or renewed upon mutual consent.

## **AREAS OF COLLABORATION**

The scope of collaboration under this MoU includes the following areas:

### **1. Student Development**

- Provision of internship programs, live projects, and industrial visits for students.
- Conduct of technical training programs in IT services and digital technologies.

### **2. Skill and Knowledge Sharing**

- Joint organization of workshops, seminars, guest lectures, and technical events.
- Knowledge sharing through industry expert sessions and panel discussions.

### **3. Curriculum and Faculty Engagement**

- Feedback and suggestions on curriculum design and updates in alignment with current industry practices.
- Collaboration on faculty development programs to enhance their industry exposure.

### **4. Placement and Employability Support**

- Provision of placement assistance to eligible students, including interviews, job referrals, resume reviews, and mock interviews.
- Facilitation of industry connects and career mentoring sessions.

## **RESPONSIBILITIES OF K. S. POLYTECHNIC**

The Institution shall:

1. Identify and nominate students for participation in internships, training programs, and collaborative projects.
2. Provide academic and logistical support to facilitate smooth implementation of joint initiatives.
3. Encourage and involve faculty in industry-aligned training and development activities.
4. Coordinate all necessary arrangements for conducting on-campus events under this MoU.

## RESPONSIBILITIES OF RAPSOL TECHNOLOGIES PVT. LTD.

The Industry Partner shall:

1. Offer **internship and project opportunities** to selected and eligible students of K. S. Polytechnic.
2. Collaborate in conducting **workshops, expert lectures, and industry talks** on relevant technologies.
3. Provide **technical mentorship and project guidance** to students and curriculum-related inputs to faculty.
4. Extend **placement support for eligible students**, including opportunities for job interviews, referrals, and career guidance.

### GENERAL TERMS

1. This MoU is not intended to create any legal or financial obligations / liabilities on the part of either party.
2. Either party may terminate this MoU by providing a **30-day written notice** to the other party.
3. Any extension, amendment, or modification of this MoU shall be made in writing and signed by both parties.
4. Both parties agree to maintain confidentiality and act in good faith throughout the collaboration.

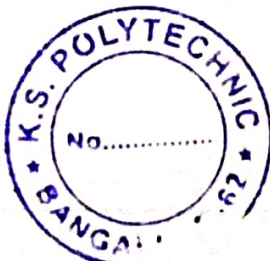
